THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 514/2014 of the European Parliament and of the Council of 16 April 2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management¹, and in particular Article 14(7) thereof,

Whereas:

- (1) Commission Decision C(2015)1658 approved the national programme of Slovenia for support from the Asylum, Migration and Integration Fund for the period 2014 to 2020 submitted on 13 March 2015 and set the maximum contribution from the Asylum, Migration and Integration Fund to the national programme of Slovenia.
- (2) To address the most pressing needs and to ensure the implementation of the migration priorities, the Budgetary Authority reinforced the 2017 Union budget with EUR 1 130 million for the Asylum, Migration and Integration Fund.
- (3) The additional allocations to the national programmes are made in accordance with Annex I of Regulation (EU) 516/2014 of the European Parliament and of the Council².
- (4) On 19 May 2017 Slovenia submitted, through the Commission's electronic date exchange system (SFC2014), a revised national programme to take into account the additional Union contribution.
- (5) This Decision constitutes a financing decision within the meaning of Article 84 of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council³ and a legal commitment within the meaning of Article 85 of that Regulation.
- (6) Decision C(2015)1658 should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Decision C(2015)1658 is amended as follows:

(1) Article 1 is replaced by the following:

"Article 1

The revised national programme of Slovenia for support from the Asylum, Migration and Integration Fund for the period from 1 January 2014 to 31 December 2020, as submitted in its final version on 19 May 2017, is hereby approved."

(2) Article 2 is replaced by the following:

"Article 2

- 1. The maximum contribution from the Asylum, Migration and Integration Fund to the national programme of Slovenia is set at EUR 19 928 072, to be financed from budget line 18 03 01 of the general budget of the Union.
- 2. The maximum contribution shall be composed of:
 - (a) a basic amount of EUR 14 725 477 as referred to in Annex I to Regulation (EU) No 516/2014;
 - (b) an additional amount of EUR 200 000 for the Union Resettlement Programme, allocated in accordance with Article 17 of that Regulation;
 - (c) an additional amount of EUR 3 402 000 for the relocation of applicants for international protection from Greece and Italy in accordance with Article 10 of Decision (EU) 2015/1523 and Article 10(1)(a) of Decision (EU) 2015/1601;
 - (d) an additional amount of EUR 1 600 595 allocated in accordance with Annex I to Regulation (EU) No 516/2014."

Article 2

This Decision is addressed to the Republic of Slovenia.
